Clarifications issued by this Addendum:

- 1. Specification Section 05 12 00 Structural Steel Framing, Section 1.5 C. 1. b.: "The cost for special inspection fees incurred during fabrication shall be reimbursed to the owner by the contractor." Meaning; the contractor will reimburse the owner for the additional "In plant" fabrication inspections that are required for a Non-AISC Certified Fabricator. This does not change the infield requirement for special inspections and structural testing by the owner's contracted inspection company. Specification section 13 34 19 Metal Building Systems require the manufacturer to be accredited under IAS AC472 per section 1.5 G. These requirements will NOT be waived regardless of the fabricators' number of years' experience.
- 2. Building permit and utility tap fees to be paid by Owner.
- 3. Owner will be responsible to fill the new diesel tank after the completion of construction.
